Most of us share a love of wildlife, be it in the form of birds, mammals, plants, insects or all of the above. We're used to peering through binoculars or crouching down to inspect some small spark of life we've discovered in the grass. But how often do you look around you and marvel at the very thing that makes all of it possible, our magnificent planet Earth? Most of the time, it's difficult. We can only see our own little patch of ground and sky, big enough for us to inhabit, perhaps, but not big enough for us to really appreciate where we live.

If you have some spare time, I strongly urge you to do what at first might seem contrary to taking the larger view: I want you to stare at your computer monitor. But for once, don't let it be Facebook or Youtube or Pinterest. Instead, try this site: [eol.jsc.nasa.gov/HDEV/](http://eol.jsc.nasa.gov/HDEV/) If you try it and see only black or gray on the screen, please wait a few minutes or check back in about half an hour. I promise it will be worth it.

This site gives us the unprecedented ability to see the Earth from the International Space Station. And what a spectacular marvel it is! Swirls of blue, white and brown glide under our eyes. The sheer variety of cloud patterns is mind-boggling. The curve of blue against the stark black sky is a work of art. And you can see darkness fall in fast-motion, followed about half an hour later by sunrise. As you gaze at your monitor, you begin to get an idea of what a fantastic place our planet is and why it's worth our protection. Nothing this beautiful should be allowed to wither and die.

National Audubon has released its climate change report and it's a little scary. But there's still time and hope. As long as we can understand what we're protecting, how big and beautiful and important it is, certainly all is not lost. Let's see what we can do.

**September Meeting Presenter**  
**Delia Lister**



This year, well over 500,000 people will proudly state that they have traveled to Alaska. However, 95% of them will have seen the sights from a cruise ship. Our own Delia Lister can truly boast that she was "Among the Five Percent: Exploring Glacier Bay National Park." She was with a handful of knowledgeable

people who certainly obtained a different and more detailed perspective of the area by hiking, kayaking, and observing glacial phenomena and wildlife up close.

In Delia's usual entertaining and informative manner, she explained the formation, anatomy, and movement of glaciers as well as their effects on the landscape. We saw photos of huge dropped rocks and ancient tree stumps; and she explained the process of succession—the stages of plant life development after the land had been scoured by a glacier—from lichen to more complex blooming plants, pines, spruces, and hemlocks.



We all know that glaciers are receding and slowly disappearing, and Delia showed us evidence of that, for example, Muir Glacier in 1895 vs. the present day. There were still opportunities for her to see jaw-dropping sights such as the 250-foot-high portion of a glacier.

In Delia's presentations we're always treated with superb photos of wild fauna and flora, and tonight was no exception—fishes, sea stars, urchins, sea otters, harbor seals, sea lions, and humpback whales from the ocean; black and brown bears, and moose on the land. And there were the birds: puffins, oystercatchers, guillemots, cormorants, and hosts of eagles.



Thank you, Delia, for taking us—virtually, anyway—where only the intrepid 5% dare to go.

## SUMMARY OF CHAPTER BY-LAWS

### Proposed Changes to Sperry-Galligar Audubon Society Bylaws (as of 24 September 2014)

The organization's name is changed from Sperry Audubon Society to Sperry-Galligar Audubon Society.

Membership in local Audubon is clarified to include to all members of a household residing at a single address. Voting privileges are extended to members 18 years of age or older. (Article I, Sec. 4)

Yearly membership continues through August 31st with a six month grace period for renewing dues. (Article I, Secs. 5, 6)

Communication may now be done through e-mail or other electronic communication rather than requiring post office mail. (Article II, Sec. 4; Article XI)

The Board of Directors is expanded to include Board Members at Large, Audubon members who attend Board meetings regularly and who are approved by the Board. (Article III, Secs. 3, 4)

The Annual Board Planning Meeting is moved from April to August to reflect current practice. (Article III, Sec. 6)

Meetings of the Board are open to all local Audubon members, as is current practice. (Article III, Sec. 8)

Provision is made for the Board to conduct time sensitive business by electronic communication rather than requiring physical meetings. (Article III, Sec. 10)

Correspondence of the Society may be conducted by Officers and Committee Chairs, not only by the Secretary. (Article IV, Sec. 5)

The Treasurer may write checks with her signature alone on a portion of the Society's funds (reflecting current practice) rather than also requiring the signature of the President. (Article IV, Sec. 7)

The Board of Directors, not a nominating committee, selects candidates for office. (Members may also nominate candidates.) (Article V, Sec. 1)

Standing Committees are no longer required to have more than one member. (Article VII, Sec. 1)

Duties of the Membership Committee and Publicity Committee are redefined. (Article VII, Sec. 3)

### 2014 BLUEBIRD CENSUS

Bob Mangile gathers information on bluebirds and nesting activity in the area to place on the Sperry-Galligar website. The Bluebird Trail Managers' Final Report for 2014 was produced by Elma Hurt, the Bluebird Lady. A total of 357 bluebird fledglings



for what was thought as a bad year was a bit of a surprise. The report stated, however, that no one on the Bluebird Trail Managers' team was able to raise a single bluebird to adulthood this year. The average number of fledglings per box for the 136 boxes reported was 2.6 fledglings. Elma Hurt reported that she lost 100 bluebird eggs for various reasons. Predators may have contributed to this huge loss. Could the ups and downs of temperature and rain affected the fate of the bluebirds. Hopefully, next year will be more productive.
